Boat Inspection Data

In the Adirondacks 44,370 Boats have been inspected. A 37% decrease from the same period last year.

Lake Placid State Launch is the third busiest after Second Pond and Great Sacadonga

2021 Lake Placid Steward Data YTD July 21, 2021 (comparison figures from 2020 in red)

- 2,264 (3,489) boats inspected down 35% from similar period in 2020. 75% (86%) from the Sate Launch and 25% (16%) from the Village Launch.
- 1,419 (1,981) boats launched into Lake Placid, 725 (872) motorized and 694 (1,109) non-motorized. Sevetneen % drop in motorized boats and 37% drop in non-motorized boats
- Of the 725 motorized boats only 94 (151) had been in a different body of water in the last two weeks. 7 (6) had organisms and 2 (3) had invasives all other than VLM.
- Of the 694 non-motorized boats, 133 (600) had been in a different body of water. 6 (1) had non-invasive organisms.
