Note from the President

As we all wait for 'ice out' the SOA has been busy finalizing our critical water quality programs for the summer of 2023.

We have contracted with our dive services team to conduct three invasive species 'harvest' dives, received a grant from the Lake Champlain Basin Program to support our Lake Stewards Program, and renewed our contract with Paul Smith's College to manage the Lake Stewards at the NY State DEC and Village boat launches.

Thanks to our volunteers Mark Wilson and Mary Thill, the SOA is once again

registered to participate in the Citizens Statewide Lake Assessment Program (CSLAP), a lake monitoring and education program managed by the DEC. Volunteers take water samples over the course of the summer that are tested for chemical properties and clarity and monitored over the years.

During the summer of 2023 wave action on the lake will be monitored to assess boat activity, wakes generated, and their impact on personal safety and shore erosion. Wave monitoring was identified as an important function in our Lake Management Plan published last year. The deployment, monitoring and data

analysis will be conducted by Brendan Wiltse and his Adirondack Water Institute (AWI) team at Paul Smith's College. Funding for wave monitoring buoys was secured by a grant awarded to AWI by the Town of North Elba Local Enhancement and Advancement Fund (L.E.A.F).

We greatly appreciate your support of our efforts to protect the lake and its residents and visitors and look forward to seeing you out on the water.





Q&A with Our Lake Constable, Buzzy Rickard

Question: What is the key responsibility of the Lake Constable? Answer: Try to ensure safety for all people using the lake; educate boaters of the laws; respond to questions or concerns.

Question: What boater safety concerns do you have given your experience on the lake in 2022?

Answer: Any lack of consideration on the part of a vessel operator can lead to an unpleasant or unsafe experience on and off the water. Failure to have a personal flotation device (PFD) when using paddle boards, canoes and kayaks.

Question: What should shore owners be aware of when boating this summer to keep the waters safe?

Answer: Shore owners have the opportunity and responsibility to exhibit and set the example of respectful boating etiquette.

For example:

- · Remove floating debris from the lake whenever possible
- Maintain a safe distance and speed when in close proximity to other boaters.
- · Be aware of NYS Boater Safety Rules and Regulations.

- Be aware of your wake, especially when approaching paddlers. A constant speed with "Bow Up" is never good.
- Keep a respectful distance of at least 100 feet from docks and boathouses.

The Lake Placid Lake Septic System Inspection Law requires that all septic systems proximate to the lake be inspected every three years for year-round residences; every five years for seasonal properties; if there is a reason to believe that a septic system is not functioning properly; and when the property is conveyed to a new owner.

A Fond Farewell to Recently Departed Members of Our Community

Rosemary Agnes Donohue Reiss of R-Camp passed away on January 15 in West Hartford CT at age 89. Born in the Boston area, she spent childhood summers at Newfound Lake, NH where she first enjoyed a peaceful paddle, as she often did later in life on the west lake. Rosemary graduated from Emmanuel College, and earned a masters in theology from Fordham University. She married Lake Placid native Paul Reiss in 1955 and their growing family traveled from Wisconsin to Lake Placid every summer before moving to the NYC suburbs and doing likewise.

Rosemary taught high school religion for many years once most of her nine children were grown. When Paul became President of St. Michael's College, their commute to Lake Placid shrunk again. Over many decades, Rosemary helped welcome hundreds of children at the summer camps of the Julian Reiss Foundation. She also served actively on the board of the Lake Placid Sinfonietta and was a devoted supporter of Mercy Care for the Adirondacks.

From her teens until her early 80s, Rosemary was a selfless caregiver beloved by many of all generations who already miss her steady, kind inspiration and generous spirit. In addition to her beloved husband, a sister and a brother, she

leaves three daughters, six sons, 30 grandchildren, and 10 great grandchildren, all of whom enjoy spending vacations in Lake Placid.

Elizabeth Linton Thomas "Liz" Ackerman, 93, formerly of New Vernon, NJ and recently of Shelburne, VT died on February 6th. The daughter of Catherine (Harrington) and Hassan Seeley Thomas, she was born in Springfield, MA. Elizabeth graduated Phi Beta Kappa from Elmira College and through a Ford Foundation Fellowship, earned a Masters degree in Education from Cornell University. She taught elementary school in White Plains, NY and told everyone how much she loved her first graders.

In 1956, she married David H. Ackerman (who predeceased her in 2013), the author of a book on the history of Placid Lake and co-founder, with Dr Howard Smith of the Placid Lake Foundation, now the Adirondack Land Trust. The Ackermans raised their two children, Jane and David, in New Vernon, NJ and Lake Placid, NY with a camp on northeastern Buck Island. When her children were mostly grown, Elizabeth owned and managed a ladies' dress shop in Morristown, NJ. She was a member of the Garden Club of America in Lake Placid.
